

Steps for Earning Professional Credentials through Project Management Training

Step 1: Meet educational and project management experience requirements specified by PMI

Step 2: Agree to adhere to a code of professional conduct

Step 3: Pass a rigorous multiple-choice exam designed to objectively assess and measure your ability to apply project management knowledge.

Step 4: Maintain the active credential through meeting continuing certification requirements (CCR).

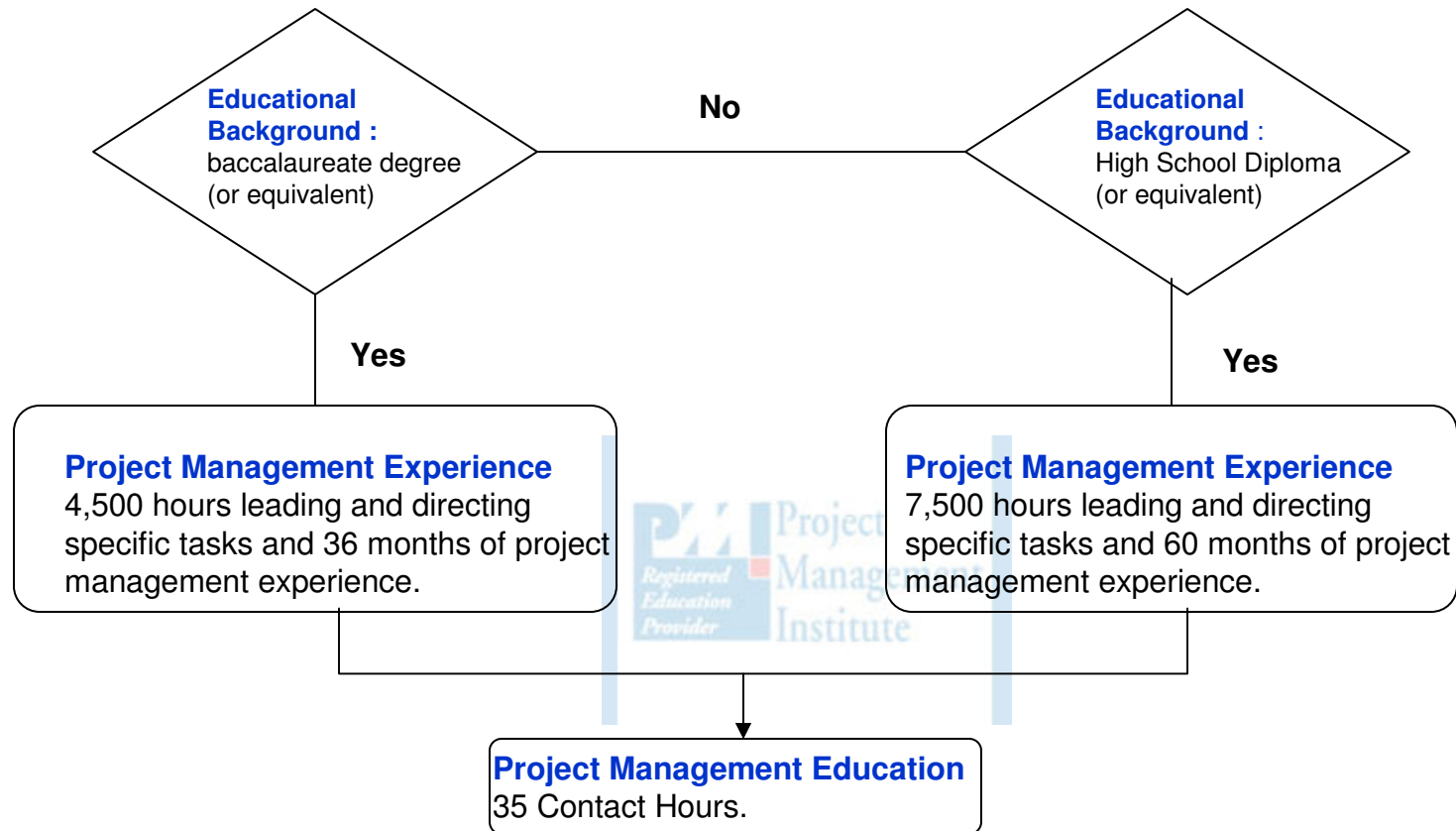
How to Proceed

1. Fill the online credential application or download the paper credential application.
(<http://www.pmi.org/PDF/PMP%20Application%20Form.pdf>)
2. Fill the Experience Verification and Project Management Education forms as part of the application.
3. If you are eligible, you will receive the eligibility notification (via e-mail) that confirms that a candidate may be eligible to take the examination.
 - Test candidates have one (1) year from the date their application is approved and processed to take the examination. This date is printed at the top of the first page of the eligibility letter.
 - Candidates may take the exam a maximum of three times within their eligibility period. If they do not pass the exam, candidates must apply again via the re-examination form.
 - If a candidate's eligibility lapses before taking the exam, the candidate must re-apply.
4. Applicants who are deemed eligible to sit for the CAPM or PMP Examination (candidates) will receive a scheduling notification along with their eligibility letter.
5. Schedule the exam at a testing center. Click here to find a testing center near you.

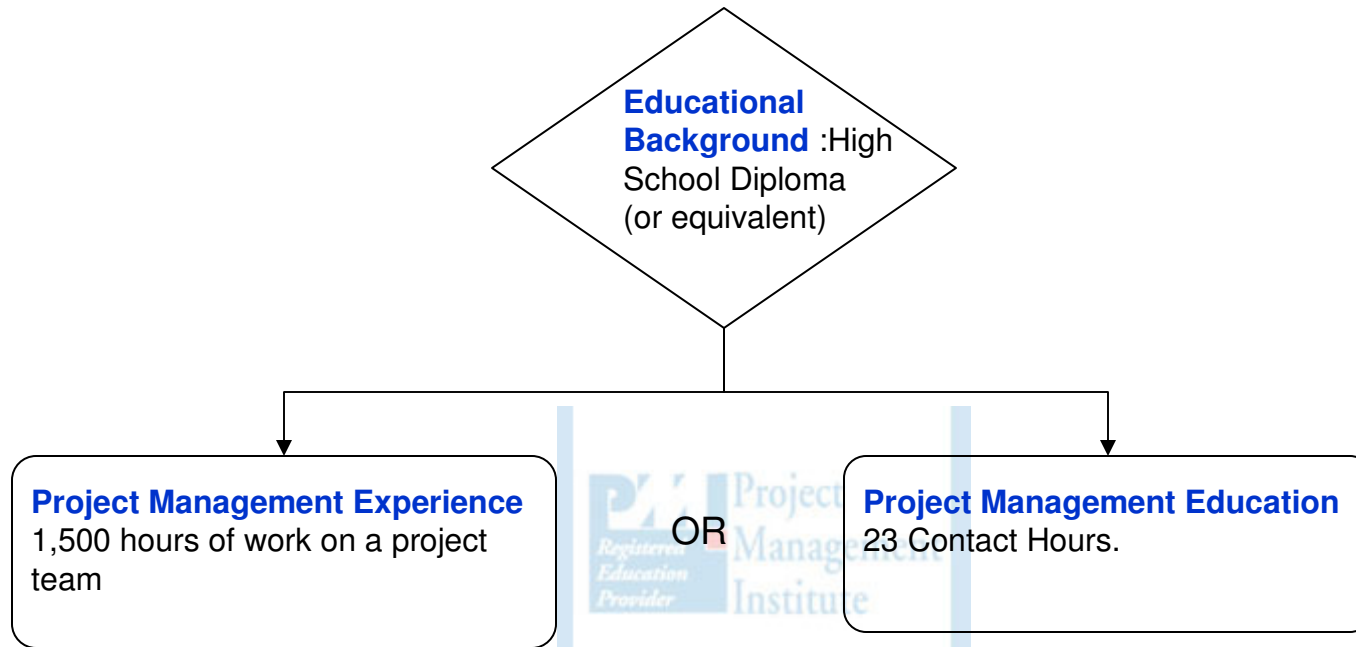

Continuing Certification Requirements (CCR)

- The PMI Continuing Certification Requirements Program (CCR) supports the ongoing educational and professional development of PMP® certificants.
- In order to satisfy CCR program requirements and maintain an active certificant status, individuals who have attained the PMP credential must
 - Accrue and report a minimum of 60 professional development units (PDUs) during each 3-year CCR cycle
 - Complete an Application for Certification Renewal and payment of the renewal fee
 - Reaffirm the Project Management Professional (PMP®) Code of Professional Conduct.
